

Agency Agreement


This Agreement sets forth our mutual intentions regarding the creation of an agency relationship between **Chengdu Rightol Media & Advertisement CO., LTD** (hereinafter "Agent"), a Chinese company with its primary place of business at 6-1-2801, No.66 Ruilian Road, Chengdu, P.R.China and Fordevind publishing house (hereinafter "Proprietor"), an Russian corporation with its primary place of business at Saint-Petersburg, Izmailovskiy pr. 29.

Proprietor hereby grants Agent the exclusive license to sell the Chinese translation rights of the 10 (ten) books listed in the Appendix to the Agreement (hereafter referred to as "the Work").

Both Parties hereto agree as follows:

1. Proprietor hereby appoints Agent as the agent to sell the Chinese rights of Work, with an authorization period of 2 years. When the authorization period expires, if neither party claims termination, the authorization period shall automatically extend for 1 year.
2. Proprietor will have the obligation to pay after the expiration or termination of this agreement all sums properly due to Agent by virtue of every deal entered by Agent or Proprietor pursuant to offer solicited by Agent during the term of the corresponding deals. Agent in turn undertakes the similar liabilities towards the Proprietor.
3. Proprietor undertakes that Proprietor has been authorized and granted by the authors or other copyright owners of the Work to sell subsidiary Chinese copyright of the Work. In the event that Proprietor is involved in copyright disputes, Proprietor shall absolve and indemnify Agent, and compensate for all damages if Agent suffers consequent losses.
4. During the authorization period, all the Chinese copyright license agreements shall be signed by Proprietor, Agent and the copyright purchaser; otherwise the copyright license agreement shall be invalid.
5. Agent shall supervise the copyright purchaser to pay the royalties and relevant fees to Agent's account in due time, and wire to the designated account of Proprietor within 60 working days after receiving the payment.
6. Agent shall be entitled to a commission of a 15% of the gross income received from Chinese copyright sales.
7. Provided that the currency in copyright license agreement is not made in US dollars, Agent can pay Proprietor by exchanging currencies for US dollars based on the exchange rate on the payment date. Proprietor shall be responsible for the bank charges (US \$30 for each transaction) with respect to the payment of Agent to Proprietor. The amount of a single transfer from Agent to Proprietor should be not less than \$500 USD. In case if Agent has not collected this amount the deadline can be extended until the minimal amount accumulated with the agreement of



Proprietor.

8. This agreement shall be interpreted in accordance with Chinese Law. In case of any dispute arising from or related to this agreement, mediation or arbitration shall be awarded through legal institutions acknowledged by both parties.
